It is, first and foremost, a history of events and their impact on national policy. It is also a history of the Joint Chiefs of Staff themselves and their evolving organization, a reflection in many ways of the problems they faced and how they elected to address them. Over the years, the Joint History Office has produced and published numerous detailed monographs on JCS participation in national security policy. There has never been, however, a single-volume narrative summary of the JCS role. This book, written from a combination of primary and secondary sources, seeks to fill that void.
