The challenge is to move beyond the realisation that moral panics are not rationally constructed to an analysis of the passional bases of the social order, and to an understanding of how our politics might deal with this without itself falling into the contagion of panic. The diverse collection of essays gathered together in this edition takes up that challenge.
