You must also provide each shareholder with Form 1065, Schedule K-1. Members report income they received from the LLC on their individual returns.

If the LLC is a corporation, normal corporate tax rules will apply to the LLC and it should file a Form 1120, U.S. Corporation Income Tax Return. The 1120 is the C corporation income tax return, and there are no flow-through items to a 1040 or 1040-SR from a C corporation return.

do this.
